BHHS Florida Realty's Luxury Collection Program *Qualifications*

How does a home qualify?

In order for a home to qualify for the Luxury Collection Program, the listing must meet the following criteria:

- Priced in the top 10% of market in which it is located (per table below) throughout the duration of the listing
- A minimum of a 6-month listing
- A minimum of 3% commission on the listing side
- Original architectural renderings if under construction
- No vacant land / tear downs
- No assignable contracts (flips)
- No commercial (rental properties)

Other requirements and advisories

- The Luxury Collection application must be completed in full, signed and <u>submitted by the branch manager</u> and must be accompanied by a copy of the listing contract and MLS print out.
- The Marketing Department must receive all completed paperwork **within two weeks** (or 14 days) from the date the listing contract is executed.
- Professional photos and virtual tours are 100% paid by BHHS Florida Realty as follows: Standard virtual tour which includes 5 panoramas and 6 still photos. If the property is under construction, an original architectural rendering must be submitted at the time the application is sent over.
- As soon as the Luxury Collection Application is approved and processed by Marketing, professional photos are ordered. BHHS Florida Realty is not liable to pay for professional photos ordered by sales professionals. The photographers will not shoot the tours before the properties are entered into the vendors system. Your help is requested to maintain good relations the photographers, so please refrain from asking them to photograph before the listing has been entered into the system.
